***I Understand that: -***

**Before and After School:**

The schoolyard is supervised **from 8.30am** until school begins and **until 3.15pm**. The school will not be able to take responsibility for children in the yard before 8.30am and after 3.15pm unless they are enrolled in OSHC.

**Behaviour Management:**

The school's Behaviour Management Code is designed to protect the rights of all students to learn and to keep children safe and happy. For persistent disruptive behaviour, non-compliance, dangerous and/or illegal behaviour, it may be necessary to send a student home.

**Internet:**

My child will be provided with opportunities to access sites on the Internet. It is expected children **will only** open appropriate sites as approved by the teacher. Consistent, inappropriate use of the internet will mean my child's access will be limited and/or suspended.

**Testing and Learning Programs:**

My child may be tested and/or withdrawn from class to be involved in learning programs, which may involve working one to one or in small groups with another adult other than the class teacher.

**Uniform and Hats:**

The wearing of the school uniform is an expectation, and I will ensure my child is appropriately dressed. I understand that if my child wears an inappropriate shirt to school he/she will be given a clean school shirt to wear for the day. I understand that a wide brimmed / bucket or legionnaires hat is compulsory to wear throughout the whole year for any outdoor activities.
